**WHEREAS** the Municipality of Kincardine has offered to host a Deep Geologic Repository (DGR) of low and intermediate level nuclear waste at the Bruce Nuclear Power Station site, supported by Ontario Power Generation (OPG);

**AND WHEREAS** concern has been expressed by other Municipalities in both Canada and the United States of America, as well as individuals, and citizen and environmental groups;

**AND WHEREAS** the Town of Kingsville in the Province of Ontario, shares many of those concerns, including, but not solely related to, the risk of embedment of nuclear waste at a site less than 1 kilometre from the Great Lakes, a source of drinking water to 40 million people and supplying 21% of the world's fresh water;

**AND WHEREAS** the proposed site is in limestone above an ancient waterbed, and there has been no intensive research done on other sites available in the granite of the Canadian Shield, or elsewhere;

**AND WHEREAS** there has not been a disaster/containment plan articulated;

**NOW THEREFORE BE IT RESOLVED** that the Town of Kingsville is not in support of the Kincardine location for a Deep Geologic Repository at this time, and requests more information, alternatives and plans be presented, and more research and results be reported and critically reviewed before a final decision is made; and that this motion be forwarded to Great Lakes and St. Lawrence Cities Initiative for distribution to the appropriate authorities and interested parties, and the Town of Kingsville forward a copy of this motion to the City of Windsor, the County of Essex, Town of Essex, Town of Lakeshore, Town of Tecumseh, Municipality of Leamington, Town of LaSalle, Town of Amherstburg, Essex Region Conservation Authority, MPP Taras Natyshak and MP Jeff Watson.
